<u>SS 1 for SB 68</u>	Workers Compensation. Section 1 of the bill clarifies the obligations of independent contractors and subcontractors with respect to maintaining workers' compensation insurance, preserving the option for executive officers who are stockholders of the corporate entity to be exempted from coverage, requiring written certification of either coverage or that no insurance has been obtained by a subcontractor or independent contractor, and affixing the effective date for these provisions as of July 17, 2007. Section 2 of the bill clarifies that Subsection 2311(a)(5) does not create an employer-employee relationship, statutory or otherwise, between the contracting entity and the subcontractor, independent contractors, subcontractors, and independent contractors with respect to maintaining workers' compensation insurance. <u>SB 78</u> with HA 2	Health Insurance and Newborn Screening. This bill provides that certain medical formulas and food expenses in the on-going treatment of Phenylketonuria (PKU) and other inherited metabolic diseases shall be covered in health insurance contracts and also in group and blanket health insurance policies.
<u>SB 79</u> with SA 3	Emergency Communication Systems. The Act helps to ensure the quality of the State's emergency communications system by maintaining quality in-building communication preventing "dead zone" areas and helping to protect the citizens of the State so emergency public safety personnel can communicate.

<u>SA 4</u>	Pharmacy , including provisions relating to objectives, licensure, examination, reciprocity, complaints, grounds for discipline, hearings, and sanctions. The bill also defines a certified pharmacy technician and a pharmacy technician as supportive personnel who may work only under the direct supervision of a pharmacist.
<u>SB 87</u>	Amends Title 16, Subsections 9304, 9305, and 9312 relating to the Delaware Health Resources Board . The bill corrects technical errors from a 2005 Joint Sunset Committee Bill that inadvertently omitted wording to enable the enforcement of charity care requirements. Additionally, the bill correctly references the dollar amount that must be triggered for the review of capital expenditures. <u>SS 1 for SB 107</u>	Updates colorectal screening modalities and retains the decisions of
with SA 1	colorectal cancer screening under the auspices of the Secretary of the Department of Health and Social Services. If passed, the bill is effective January 1, 2009.
<u>SB 108 with SA 1</u> <u>& SA 3</u>	Clarifies the role of the Office of Radiation Control , establishes progressive administrative penalties, establishes annual x-ray machine registration fees, requires any fee created by the Authority on Radiation Protection to be approved by the General Assembly and administered through the General Fund, and makes other technical changes.
<u>SB 112</u>	Exempts licensed healthcare professionals as well as trained, non-licensed persons, acting at the direction of the Public Health Authority, from the licensing statutes and regulations for healthcare professionals. This exemption is necessary to allow trained, non-licensed persons to hand-out prepackaged medications to essential workers – Delaware's first line of defense – without there necessarily being a licensed healthcare professional physically present to oversee the dispensing process. Trained, non- licensed persons include, but are not limited to, individuals from the Division of Public Health, the Delaware Emergency Management Agency, and DelDOT as well as fire services and law enforcement agencies.

<u>SB 227 with</u> <u>SA 1</u>	Creates a program for local, regional, and statewide notification of a missing senior citizen, missing suicidal person, or a missing person with a disability . The bill expands the communications network area to provide greater assistance to investigating law enforcement agencies in their searches for missing program. This program is similar to the Amber Alert for abducted and missing children.
<u>SB 235 with</u> SA 2 & HA 1	Makes cancer incidence rates available to health professionals and to the public by census tract, thereby enabling cancer clusters to be identified.
<u>SB 244</u>	Amends Title 8 of the Delaware Code relating to the General Corporation Law .

<u>SB 313</u>	Reforms the method by which criminally mentally ill adults and criminally mentally ill non-amenable juveniles are treated.
<u>SB 317</u>	Makes technical changes to the Dietitian/Nutritionist Licensure Act .
<u>SB 320</u>	Makes appropriations for certain Grants-In-Aid for the Fiscal YEar Ending June 30, 2009. Pages 25 & 26 mention the Hospital Provider Tax . (Also See <u>SB 300</u> & <u>HB 512</u>)
<u>SB 321 with</u> SA 1	Requires all medical practitioners in the State of Delaware to write their prescriptions on a tamper resistant prescription pad .
<u>SCR 7</u>	Relating to the Promotion of Better Awareness of the Food and Drug Administration (FDA) Approved Vaccination Against the Human Papilloma Virus and Cervical Cancer.
SCR 8	Proclaims the Month of May as Lyme Disease Awareness Month , and requests the Governor to issue a proclamation calling upon the people of the State of Delaware to observe the month of May with appropriate educational programs, ceremonies, and activities that will emphasize the severity of Lyme Disease and hopefully the prevention of future victims of this chronic disease.
<u>SCR 10</u>	Declares May 2007 as Melanoma and Skin Cancer Detection and Prevention Month in Delaware.

Provisions of this act are retroactive to January 1, 2007.
<u>HB 31 with HA</u> <u>1</u>	Amends Title 29 of the Delaware Code relating to State Planning and County Impact Fees by removing the prohibition against County governments establishing impact fees in certain areas of the County. Kent County Government has passed an ordinance to create an impact fee to support emergency medical services for all areas of the County, but awaits repeal of this prohibition before the fee can be enacted.
HB 36 with HA	Creates a uniform cease and desist authority for the Boards
<u>1 & HA 2</u>	(professional licensing and certification boards). The legislation further authorizes the Boards to establish and impose administrative fines against persons who violate such cease and desist orders, subject to the hearing and review procedures of this Chapter.
HB 38 with HA 2, SA 1, SA 2, SA 3, HA 3, & HA 4	Sets standards needed to become a Licensed Dietitian/Nutritionist and also establishes the Board of Dietetics/Nutrition .
HS 1 for HB 47 with HA 1 & HA 2	Creates the Hospital Infections Disclosure Act requiring hospitals to report quarterly data on hospital-acquired infection rates.
HB 57 with HA 1 & HA 2	Establishes the 2-1-1 Information Helpline to provide community social services information and referral services to a centralized location which will operate 24 hours a day, 7 days a week. The establishment of the 2-1-1 Helpline provides needed information on government and not-for-profit services that provide a variety of programs.
<u>HB 92 with</u> HA 1, & SA 1	Creates a low-cost arbitration process that health care providers can use to resolve payment disputes with insurance carriers .
<u>HB 101</u> with HA 2	Implements a requirement of the Federal Deficit Reduction Act (DRA) of 2005 to require all health insurers to provide eligibility and coverage information to the State Medicaid Agency, when the State requires such information.
<u>HB 103</u>	Updates Chapters 20 and 31 of Title 16 (Uniform Health Data) by replacing references to the Bureau of Health Planning and Resources Management with Division of Public Health.

<u>HB 130</u> with HA 1	Amend Title 11 of the Delaware Code relating to Sex Offenders and Sexual Offenses. This Act expands the definition of sexual offenses in the Delaware Code to include advancing or profiting from child prostitution. This bill also creates a separate crime, with enhanced penalties for sex offenders who commit sexual offenses against children.
<u>HB 144</u>	Amends Title 19, Chapter 33 relating to Unemployment Compensation . Sections 1 and 2 are technical amendments. Section 3 increases the taxable wage base from \$8,500 to \$10,500 effective January 1, 2008. The taxable wage base has not been increased since January 1, 1987.
<u>HB 156 with</u> <u>HA 1</u>	Changes the order in which the right to dispose of a person's last remains devolves upon a decedent's death. (Also see HB 384)
<u>HB 168</u>	Increases the amount a private business or trade school is required to post as an annual surety bond . The purpose of the surety bond requirement is to protect the contractual rights of students. This Act increases the minimum required surety bond from \$5,000 to \$25,000.
<u>HB 178</u> with HA 1	Re-establishment of a Hearing Aid Loan Bank . The Hearing Aid Loan Bank was originally established by the 142 nd General Assembly for the purpose of lending hearing aids to eligible children under three (3) who suffer from hearing impairment. The original act contained a sunset provision and ceased to be effective in December 2006. This Act re-authorizes the Hearing Aid Loan Bank to ensure all eligible children have access to hearing aids.
<u>HB 187</u>	Raises the permit fees of large industrial and manufacturing sources of air emissions for one year beginning January 1, 2008 . This one-year increase addresses a funding shortfall in the Program. Pursuant to Sub-Section 6099, Title 7, Delaware Code, the Title V Operating Permit Program Advisory Committee will meet during 2008 to review the performance and expenditures of the program and make recommendations to the General Assembly on fees for 2009 and beyond and any other elements of the Program.
<u>HB 193</u>	Updates and modernizes the authority of the Department of Natural Resources and Environmental Control relating to Mosquito Control to clarify that authority to protect the public health and well being within the limits of appropriations from the General Assembly. The bill also provides for public notice to land owners and hearing on source reduction practices.
<u>HS 1 for</u> <u>HB 194</u>	Allows the use of Mercury-containing vaccines for children less than 8 years of age or to pregnant women when an emergency occurs as declared by the Director of the Division of Public Health, or when there is no mercury-free vaccine manufactured or available for a specific disease. (See <u>HB 322</u>)

<u>HB 320</u>	Revises the membership of the Council on Services for Aging and Adults with Physical Disabilities to match exactly the qualifications for membership of the physical disability portion of the Board.
<u>HB 322</u>	Provides that vaccines containing mercury may not be given to children under 8 yeas of age or to pregnant women, except under the special circumstances described in the bill. (Also see <u>HB 194</u>)
<u>HB 329</u>	Implements the recommendations made by the State Fire Prevention Commission to the Governor in response to Executive Order No. 99 giving the Commission the authority to establish regulations governing audits of volunteer fire and ambulance companies and the power to impose sanctions for non-compliance.
HB 343 with HA 2 & HA 1 to HA 2	Amends the definition in the criminal code to include the definition of electronically-controlled devices as a dangerous instrument under State law.
HB 355 with HA 2 & SA 1	Requires individual and group health insurance contracts to provide coverage for hearing aids of up to \$1,000 per year, every three years, for covered dependents.

<u>HB 387 with</u> <u>HA 1</u>	Amends the Hearing Aid Loan Bank to expand eligibility for hearing aids to all children less than 18 years of age. Also allows the program manager to extend the original loan period for an additional 6-month period.
<u>HB 392 with</u> HA 1	Establishes guidelines for volunteer dentists, hygienists and dental assistants.
<u>HB 418</u>	Amends the Delaware Clean Air Act Title V Operating Permit Program by reauthorizing and restructuring the permit fees for facilities in Delaware and allows the Department of Natural Resources and Environmental Control (DNREC) to collect fees beginning January 1, 2009 through December 31, 2011.
<u>HB 424 with</u> <u>HA 1</u>	Amends Title 11, Chapter 39, Subchapter 11, requiring the defendant to submit to HIV testing at the request of the victim if the defendant has compelled the victim to engage in sexual activity either through force or threat of force. This bill allows the State to continue receiving Violence Against Women Act (VAWA) grant funds.
<u>HB 438</u>	Calls for the State Fire Prevention Commission to promulgate regulations requiring all persons involved in the inspection and testing of water-based fire prevention protection systems to maintain current certification in the NICET II "Inspection and Testing of Water-based Systems" certification program, and to require 16 hours of continuing education requires for every biennial renewal period.

<u>HB 446</u>	Establishes the Adult Correction Healthcare Review Committee and sets forth its purpose to provide advice to the counsel in relations to the provisions of adequate healthcare services to the incarcerated population within the State of Delaware. The bill exempts the Committee from the Freedom of Information Act as it relates to open meetings and public records. The Committee shall be required to report to the Governor and the General Assembly each year regarding the State of inmate healthcare in Delaware.

The bill also extends the timeframe from 3 months to 6 months for expedited reviews of all child abuse and neglect deaths and near deaths and provides for compliance with the Federal Child Abuse Prevention and Treatment Act requirements pursuant to 42 U.S.C. § 5106 a(b)(2)(A)(x).
<u>HB 521</u>	Amends Title 24, Medical Practice Act , to add a new subsection exempting physicians providing second opinions under the State's Group Health Insurance Program from having to obtain a certificate to practice medicine in the State of Delaware provided they are licensed in another state or the District of Columbia.
<u>HCR 2</u>	Urges Delaware's Congressional delegation to reauthorize the State Children Health Insurance Program (SCHIP) to assure federal funding for Delaware's SCHIP Program . The resolution also urges all State agencies to work to ensure that all eligible Delaware children are enrolled in the Delaware SCHIP Program.
<u>HCR 9</u>	Encourages the Delaware Medical Society to inform its members about postpartum depression and screening tests.

The workshop carries 12 continuous education credits (CEUs) and is available in New Castle, Kent, and Sussex Counties. The training is available on the internet and can be completed at one's place of employment.
