Thank you for the opportunity to comment on House Bill 305. The Delaware Healthcare Association is concerned that legalizing marijuana for recreational use could have a negative impact on the health of Delawareans.

According to the CDC, marijuana can have a wide range of effects on one's health. Marijuana has a direct impact on the brain and can impact memory, attention, mood and reaction time. These impacts can be long term, particularly if marijuana use begins before adulthood. Smoked marijuana can be harmful to the lungs and cardiovascular system while edible marijuana carries an increased risk of poisoning. Further, states that have legalized marijuana for recreational use have seen an increase in emergency room visits due to marijuana-induced psychosis and other marijuana-related illnesses in recent years. For example, Colorado's UHealth University of Colorado Hospital Emergency Department has seen a three-fold increase in marijuana cases since the state became the first to allow sales of recreational marijuana in January 2014.
